The secretary is to send our newly issued, 2017 insurance cover certificate to Bunnings and also to Bayswater Council to cover requirements for the sausage sizzle on 19 March.

General Business: Ozzy is hoping to hold a 'christening' celebration on the evening after the resurfacing of the rink is concluded.

Next year we need to ensure that the discount for early payments of the club registration applies to cash payments as well as on-line ones.

It was noted that the Margaret Hutchinson club award applies to the whole club, so can be awarded to any member of the club, not just to the Artistic Branch. Peter is to check with Carla and draw up guidelines for awarding it.

We are grateful to Di Palmer for assisting in taking registrations on the Show Skate night and passing any money collected to the committee members present on the night. It was later pointed out that the our constitution and bylaws only permit certain committee members to collect money, so we need to be ensure that an appropriate committee member is present to directly receive the money in future. Peter is to email the bylaws to Jody (to keep together with the constitution), and place them on the web with the constitution so they are readily available to all club members.
